Emerson Cargo Solutions provides customers with eco-friendly return boxes, pre-paid postage labels and any required battery shipment notification labels. Customers place units in the return box and ship it back when full. GO GreenSense takes the hassle out of returning temperature monitoring devices for recycling.

Get Ready to GO GreenSense!

- Step 1:** Call Emerson Cargo Solutions at +1 877 998 7299 to get set up. We'll provide you with return boxes, reusable postage paid return labels and any required battery shipment notification labels.
- Step 2:** Review, sign and return the Rebate Terms & Policy Agreement to your sales rep.
- Step 3:** Collect your Emerson GO Trackers and Loggers and place in rigid return boxes.
- Step 4:** After the box is full, place the return form in the box, place postage paid label on box and return. For Trackers, place UN3481 Lithium Battery Label (in color) on side of box. Contact Emerson for labels as needed.

Rebate Policy for GO Trackers and Loggers sold by PakSense, Inc. and Locus Solutions, LLC (“Emerson Cargo Solutions”):

- Customer shall return Emerson Cargo Solutions GO Trackers & Loggers on a periodic basis in accordance with this GO GreenSense Program Data Sheet attached hereto and available at <https://climate.emerson.com/en-us/products/controls-monitoring-systems/cargo-tracking-monitoring/recycling>.
- All returns shall be accompanied by a completed GO GreenSense Recycling Program form. The Customer will **NOT** receive a Rebate if the form does not accompany the shipment, as proper accounting cannot occur.
- For Tracker returns, Customer must affix UN3481 Lithium Battery Label (in color) on side of approved, rigid return box. Customer is solely responsible for ensuring proper shipping, packaging and handling of GO Trackers and Loggers sent to Emerson Cargo Solutions pursuant to the GO GreenSense Program.
- Emerson Cargo Solutions is not responsible for any fines or other fees incurred by Customer if packaging, shipping or handling does not comply with applicable laws, regulations and guidelines.
- Emerson Cargo Solutions is **NOT** responsible for providing Rebates for Trackers and Loggers that are lost during shipping or received in a damaged condition.
- Emerson Cargo Solutions will only provide Rebates for Emerson Cargo Solutions Trackers and Loggers that are returned to Emerson Cargo Solutions in good working order and capable of being recycled.
- Part numbers beginning with TX and TN are ineligible for Rebates.
- Part # TS2-TL04, TS2-TTNR, and TS2-TLNR are ineligible for Rebates
- GO Trackers and Loggers and other products not sold by Emerson Cargo Solutions shipped to Emerson Cargo Solutions will **NOT** be returned to Customer or any other third party.
- Customer must provide a current W-9 before any Rebate is processed.
- Rebate checks will be processed by Emerson Cargo Solutions within ninety (90) days of receipt from Customer of the GO Trackers and Loggers to be recycled. The Rebate check shall be accompanied by a report of GO Trackers and Loggers accepted for Rebate.
- For purposes of this Rebate Policy, “Rebate” is defined as payment from Emerson Cargo Solutions to Customer for Trackers and Loggers purchased by Customer and/or Customer’s Supplier(s) for which Customer’s Suppliers then invoices Customer.

By signing this Emerson Cargo Solutions Rebate Terms and Policy, Customer agrees to all terms and conditions including the Emerson Cargo Solutions Rebate Terms and Policy and the GO GreenSense Program Data Sheet. No other terms apply.
